General Terms & Conditions for 3rd IT EXPO – GiTA.

1. The allocation of trading stalls within the EXPO is at the sole discretion of the organizers who reserve the right to allocate trading stalls at their own discretion. Preferably the allocation could be based on FIFO.
2. The organizers have the right to refuse any application for a stall and also reserve the right to cancel any such application or to decline at any stage to admit an applicant.
3. All the rates offered for the stall are pre-tax. Service Tax & any other Government tax is additional & shall be chargeable if applicable. Booking with 100% stall booking fees (**non-refundable**) will reserve the stall on your name and the letter of confirmation shall be provided after the authorized verification.
4. The cheque or demand draft to be drawn on the name of “Gandhidham IT Welfare Association” payable at Gandhidham. No cash is admissible.
5. The organizers reserve the right to change the layout of the EXPO or stalls without prior notice when necessary.
6. You shall be provided 2Nos. Table, 2 chairs & 1 Electric Board (Bed if required).
7. The subletting of stalls within the EXPO is strictly prohibited unless the organizers have granted prior written agreement.
8. The organizers have the authority to close down any stall run by an applicant who, in the opinion of the organizer, has infringed the any regulations connected to the event or has been guilty of unfair, dishonest or unseemly conduct.
9. Access to and from, except the EXPO, is strictly controlled and is only permitted during certain hours - the details of which will be confirmed to Stall holders.
10. Under any circumstances, offensive/obscene material, not to be exhibited or offered for sale.
11. No ‘roving sales’ or trading from stall other than the stall allocated to the stall holders by the organizers are permitted.
12. Stall holders are not permitted to bring any flammable, explosive, toxic or oil-based substances including gas bottles or generators without the prior consent of the organizers. Failure to comply may result in ejection from the site and recovery of any remedial costs.
13. No tobacco (Smoking or chewing) is allowed inside the EXPO area.
14. Stall holders have to be responsible to keep the EXPO area clean and have to use the nearby Dustbin to through the waste.
15. Stall holders must be set up and be ready at least one hour before the EXPO opening time i.e. 10 AM to 10 PM.
16. Stall holders must leave all sites in the condition in which they were found. Any damage will be assessed by the Organizers and the cost of repair will be charged to the stall holder and shall be payable on demand.
17. The Organizers shall not be liable for any loss of or damage to, any exhibits, or to any property belonging to any stall holder, however so arising.
18. The organizer's liability arising from the cancellation of the EXPO, or the failure or inability to provide a Site, or the subsequent cancellation of an application for a Site, shall be limited to the amount of the Site fee.
19. The organizers reserve the right at all times, to access any stall for the purpose of carrying out a safety inspection in order to satisfy themselves that applicable laws and statutory requirements are being observed.
20. Any special requirements should be submitted in writing and sent with your application form.
21. Stall holders offering any products must have approval of appropriate authority or government of India.
